Chair's Report ~ Summer 2011



I hope you are all enjoying the sunshine as we enjoy the summer months and are managing to have a well earned rest and holiday! So it is the time of year for our summer ISPO UK bulletin...

Work continues in earnest by myself and the committee for the ISPO UK society and its members.

In early July I attended the All Parliamentary Limb Loss Group at the House of Commons. One of the key items for discussion was a report given by Dr. Andrew Murrison on the prosthetic services for military personnel who have lost limbs while serving. He was unable to fully report on the content of the report at the meeting but informed the group that there were 12 main recommendations and that the report was now with David Cameron. He reflected that he had personally gained a huge insight in to prosthetic services by compiling the report and the key areas he identified were the importance of the relationship between prosthetist and amputee, patient choice and that amputees should be able to remain with their prosthetist and the significance of socket comfort. Dr. Murrison was aware of the view that there may be the potential of developing a two tier service but reassured the group that his recommendations will avoid that as far as possible. The lack of nationally agreed guidelines had become apparent and he felt that developing national guidelines may help reduce the geographic variation of service in the UK. Dr. Murrison agreed to present his recommendations to the group at a future meeting and finished by suggesting the possibility of a "Centre of National Excellence" for prosthetic provision which would be appropriately located and resourced and provide a focus for research.

Other items discussed were the changes to the Disability Living Allowance and John Reid (Limbless Association Chair) fed back numerous concerns from users. Questions were raised regarding the new system and the clinical assessment process i.e. who will carry out the assessments and when will these be done. There may be general practitioners contracted to carry out these assessments who have very limited experience with amputees and their needs. Also the current passport system for certain groups of people e.g. quadrilateral amputees, those with spinal cord injury has been stopped. The issue was raised that the DLA is provided to help people participate in life but that at present there are not sufficient therapists to assist people in returning to work. The meeting closed with a very interesting presentation by Margaret Hickson, Advisor to the London Mayor regarding the Paralympics and Olympic Access in London. The project started in 2003 and Ms. Hickson presented some of the key areas with the aim of creating the most accessible and all inclusive games ever, with the promotion of really good positive practices not just obeying minimum standards.

London businesses are being encouraged to review their accessibility, there are huge improvements being made to the South Bank area and an "Inclusive London" website has been developed which is already in use and is an extremely useful resource for visitors to and people living in London. The web site provides a huge amount of information about London businesses and access and includes a trip advisor section for feedback.

As previously advertised our next annual scientific meeting on the 7th and 8th October 2011 will be held in London for the first time in many years at the W12 Conference Centre in Hammersmith. The programme is nearly complete and there will be a session on prosthetic feet, a focus on the impact of diabetes and management of the diabetic patient and Jason Highsmith, our Blatchford lecturer, will come from the USA to present a review of the current literature relating to the Otto Bock "C" Leg. The OETT lecture will be given by Professor Andrew Boulton on the management of the diabetic patient. The exhibition will provide an opportunity for delegates to meet with prosthetic and orthotic companies and review new products. The annual meeting is a great opportunity to bring ISPO UK members together and I very much hope that the committee can rely on your support of our meeting in October and look forward to meeting you there! We will follow the days programme on Friday with an evening meal at the Ramada Hotel in West London and hope that you will join us.

The programme for the 2012 Trent International Symposium being held in May has been finalized and a call for papers circulated. The programme offers a good variety of speakers and topics and is on course to be a highly successful meeting as in previous years. We are also working on a one day course on medical issues in amputee management which is planned for Tuesday 6th December 2011 to be held at Roehampton ~ more details will be published soon.

Discussions regarding a more collaborative event for 2012, our 40-year anniversary, with both BAPO and BACPAR have begun and this will be an exciting opportunity for many of us working in the field of prosthetics and orthotics in the UK to come together and share practice and new innovations. The president of ISPO, Jan Geertzen has agreed to join us and as soon as we have details of dates we will be publishing them widely as this will be an event not to be missed! If the membership has any ideas about topics for inclusion at future scientific meetings, then please do let the committee know.

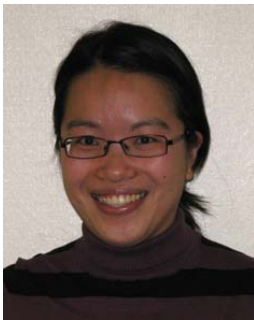

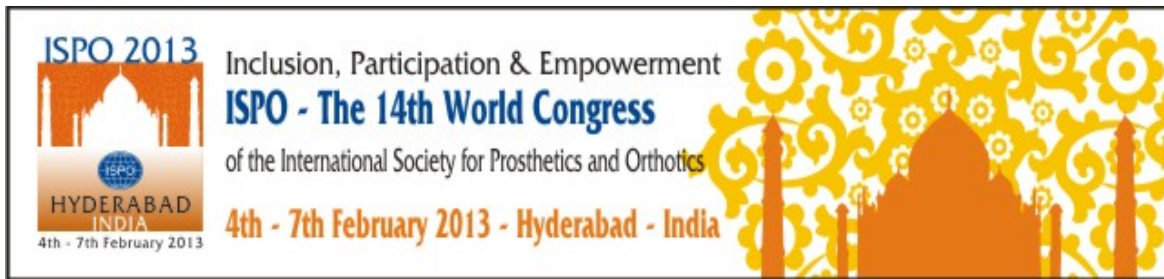

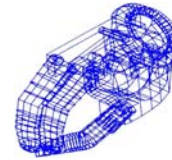

LONDON SOUTH BANK UNIVERSITY LAUNCHES CLINICAL TECHNOLOGY COURSE WITH OPEN DAY

London South Bank University's (LSBU) Faculty of Engineering, Science and The Built Environment is proud to announce the launch of a new Foundation Degree in Clinical Technology this September.

The validated two-year course has been developed to support technical and support staff who are already employed within the rehabilitation sector, including prosthetics, orthotics, and special seating.

An Open Day, which will include talks from the Course Director, LSBU's Dr Geoff Goss, and a number of top industry names, will be held on LSBU's Southwark campus on Monday 20 June.

The course was developed when LSBU was approached by colleagues from the Royal Hospital for Neuro-disability, and the programme of study was subsequently designed in close partnership with the NHS, industry and the Associated Parliamentary Limb Loss Group.

It has been developed in response to a recognised skills gap. This skills gap has resulted from the shortage of apprenticeships during the 1980s and 1990s, which created an aging workforce.

The course will also help to meet the growing need for special seating, orthotics and prosthetic devices in the UK due to the increase in diabetes, neurological conditions, an aging population and casualties from conflict zones.

Students will be able to broaden and extend the experience they have already gained in the work place through four main core subject areas – mechanics, materials, manufacturing and design, and clinical rehabilitation. They will also be taught how to utilise the latest innovative technologies.

Dr Geoff Goss, of LSBU's Faculty of Engineering, Science and The Built Environment, says: "We are really excited about the launch of the new Clinical Technology course at LSBU. There is a clearly established need for this course with the industry skills gap set against a growing demand for these devices due to the dramatic rise in diabetes and an increasingly aging population.

"Technicians will be able to bring back skills to their workplace, including making the most of the latest technologies, which will not only further their own professional development but also benefit their employers too."

Jose Spring, Research and Development Coordinator at the Royal Hospital for Neuro-disability, says: "The Royal Hospital for Neuro-disability appreciates LSBU's enthusiasm in providing training on special seating, which is not provided anywhere else in the UK. It will be an extremely well-rounded course, for the first time, spanning both the faculties of Health & Social Care and Engineering."

Michael O'Byrne, Chief Executive Officer of the Ability Technology Group, says: "This is a much needed development for the training and education of technicians. It creates the opportunity for progression for technicians who wish to commit to this initiative. I believe it will be well supported by employers."

Steve McNeice of the Associate Parliamentary Limb Loss Group says: "This innovative and aspirational course will provide many new skilled caring healthcare professionals hopefully for some years yet to come, improving the quality and range of services provided to patients and individual patient outcomes and quality of life."

Students can only be accepted onto the course if they are able to undergo work-based learning.
