CHAIRMAN'S REPORT - April 2017

The 45<sup>th</sup> year of ISPO (UK) is proving to be an interesting time for our industry. National and Global uncertainty is the backdrop to a number of complex and interconnected challenges that the P&O field is facing. The need for collective response is obvious. All our endeavours need to align our actions towards the creation of harmonious, affordable and sustainable solutions. Technology may be a key!

Users, being at the centre of any future solutions, have needs which are for their lifetime and are subject to change with both lifestyle and demography, as well as individual conditions. These are seen as ever increasing demands for customisation, accurate prescription, better reliability, flexibility, and the consistent provision of services. Hence the need to share best experiences across the UK!

Economically at global level, humanity has never been healthier, yet with progress, as Henry George indicated, comes poverty. The pressure to reduce resources sometimes impacts on interactions and gives rise to separation in contrast to the need for combining forces for an efficient response to meet the needs. Our first step is to include inclusion of BAPO's key aims into our three year strategy and work towards joint events!

The Government is proposing to reduce funding for university courses in P&O, which will add to a long term shortage of Prosthetists and Orthotists. There is already a shortage of rehabilitation technicians as well as medical consultants to lead the services. These shortfalls are forecast to go beyond the UK shores with similar experiences already reported from Norway to USA. Yet the number of patients is rising!

Taking prosthetics as an example, the WHO state there are 10 million amputees worldwide, with an estimated global Prosthetist workforce of 10,000. Assuming each caters for 300 patients a year, there will be 7 million amputees without conventional cover? The role of the Multi-Disciplinary Team, education and training, standards, sharing best practices, consensus, and innovation has never been as critical as now. We need a solution!

The ISPO World Congress in Cape Town (8-11 May) will be the ideal forum to discuss these challenges in more detail. I hope many of you can share in the discussion and provide input into shaping a new canvas for the future of P&O and the potential newly enhanced role of MDT. The session on Standards will cover not only ISO led work, but also WHO UN work. The Lower limb amputation Consensus will be another interesting session.

Dr Stephen Kirker, Scientific Chair of the 2017 annual meeting, to be held in Cambridge on 8 & 9 September, is currently finalising the programme (a draft follows in this newsletter). This joint O&P meeting will discuss clinical outcome measures, and include presentations covering neuromuscular measurement, and gait movement analysis. The research in virtual rehabilitation cognitive load in O&P, and review of equity of practice's outcome will also be covered.

Another area of development has been children's prosthetic research. NIHR work in establishing requirements is supported. The focus is on growing needs of the child amputee, and mitigating risk of musco-skeletal deformation, stage development with age, users freedom of choice, independence while growing and with change of activities and lifestyle and participation in a variety of sporting activities.

With the introduction of the MPK policy by the Specialised Commissioning Oversight Group, the need for collection of Big Data on the overall outcomes, and creation of an Open Access data bank for future researchers has been explored. ISPO's role in facilitating and coordinating between universities and service providers as well as industry is anticipated to attract more young researchers in O&P.

Finally, with our finances in good steading, ISPO UK has been able to offer several membership bursaries and travel bursaries. I encourage you to apply for these. Whilst our membership numbers remain fairly static, we do have a fair proportion of Medical Rehabilitation Consultants, Biomedical Engineers, Prosthetists, Orthotists, Physiotherapists, OTs, Rehab Engineers, Directors and Students. But we must continue to work hard to make P&O attractive to the young....

The abstract should consist of **not more than 500 words**, 12pt, justified with single spacing, double spacing for paragraphs and on A4 paper. A 25mm margin should be left on all sides. Discipline and affiliations should be stated for each of the authors and the presenting author should be in **bold** type.

The abstract is the only means by which a proposed paper can be assessed and, therefore, it should be complete in itself. It should be structured along the following guidelines:

- Aims and objectives of the study, case study or survey or a brief outline of why the work was undertaken.
- The techniques or methods used and the subjects studied.
- An indication or a summary of the actual results. It **will not** be sufficient to include phrases such as "the results will be discussed".
- Conclusions or recommendations or implications arising out of this work.

A maximum of two references may be included and they should be presented in the format used in the journal of ISPO entitled "Prosthetics and Orthotics International."

Acceptance of abstracts will depend upon these instructions being complied with. In order to be eligible to present your paper you must be registered for the meeting on the day of presentation. The abstracts may be edited for inclusion in the Compendium, which will be included in the delegates' pack. Authors are reminded, in their own interests, to pay particular attention to the layout and quality of typing.

#### ISPO collaboration with the International Organization for Standardization

ISPO and the ISO/ Technical Committee (TC) 168 Prosthetics and Orthotics work together on the development of International Standards and Projects to overcome the global challenges of increasing mobility and independence of life of people with disabilities. This is a Joint Committee with CEN TC 293 linked to working group 5 enabling developing harmonisation of the standard generated with EN standards.

#### The work aims at:

- Harmonising the best O&P practices across the globe
- Providing sustainable rehabilitation through raising education
- Sharing expertise through future technologies such as telemedicine and closer integration of products and services
- Establishing future standards based on users need and closer customisation and integration of products and services.

O&P standards are created by a multidisciplinary team based on very specific needs. The Technical Committee 168 for P&O currently consists of three Working Groups (WG):

- WG 1 (responsible for Nomenclature and Classification) and WG2 (responsible for Medical Aspects) are composed of experts in rehabilitation medicine, prosthetists, orthotists, physiotherapists, occupational therapists and biomedical engineers, who are specialists with significant international experience in rehabilitation, design and development as well as education.
- WG 3, (responsible for Testing) is composed of mainly engineers with a particular interest in the development of new products, outcome measures for safety, function and utilisation of advance technology in services.
